### What do we use your personal data for?

We process the personal data (identification, contact and signature data, as well as those that may appear in the documentation accrediting their representation) of the signatories acting as Representatives in contracts, and the personal data (identification and contact details) of the persons indicated in the contracts as contact persons for notification purposes, or of any other persons who may be specified at a later date, for the purpose of managing the maintenance, compliance, development, control and execution of the provisions of a contract with the Entity.

The Entity will also process the personal data of the Representatives to prevent money laundering and the financing of terrorism in order to comply with information collection and identification obligations, as well as obligations with respect to supplying information about payments to authorities in other countries both inside and outside the European Union on the basis of the legislation in effect in certain countries and agreements executed with the same.

## Why do we use your personal data?

The legal basis that allows us to process your personal data to manage the maintenance, compliance, development and control and the execution of a contract is our legitimate interest. In the case of complying with the obligations on money laundering and the funding of terrorism, the legal basis is compliance with a legal requirement.

### How long with the Entity retain your data?

The Entity will retain your personal data during the term of the contractual relationship. Once the contract ends, the Entity shall retain blocked versions of your personal data during the statutory limitation period (usually ten years) prescribed by regulations on money laundering and funding of terrorism, as well as of the personal data of Representatives and contact persons for the statutory limitation periods for the sole purpose of handling claims or legal remedies. Once said statutory limitation periods expire, the personal data will be destroyed.

### Who will we disclose your data to?

We will only transfer your personal data to third parties if we are obliged to do so by law, or if you have previously agreed such action with the Entity.
